Welcome

Sadler's Wells is a world-leading dance house, with a spirit of creative innovation and artistic collaboration at its heart. A key mission is to fuel the evolution of dance by providing artists with opportunities to experiment, explore, and develop their practice. This summer, we are launching a new Artist Development Programme. In this first iteration, we are launching six targeted programmes all of which will be open or offered by open call to support the artistic community through non-outcome driven initiatives. This Mentorship Programme will support ten choreographers and dance makers to have six bi-monthly one-hour online mentoring sessions with an established choreographer from Sadler's Wells' network. This mentorship will last for a year-long period focussing on a specific creative question, idea, or provocation to support the mentee's professional development.

This programme welcomes artists and creatives working in dance in all its forms, regardless of pathway, training, or background. If you are interested in receiving support from a mentor to explore a specific line of enquiry related to your practice, this is for you.

The Offer

What is it?

This programme pairs an established choreographer from Sadler's Wells' network as a mentor with a choreographer or dance maker as a mentee. The mentee will receive six bi-monthly one-hour online sessions across a year-long period.

In addition, to make the session a success for those with supplementary needs, we can offer a bespoke package of access support to suit your requirements.

Mentees will be selected by open call where they will share a specific creative question, idea, or provocation that they would like input and support to explore with a mentor. The mentors have been selected by the Artist Development team at Sadler's Wells.

Who is it for?

We would like to support choreographers and dance makers that:

- **Are interested in developing their practice and have a specific question, idea, or provocation in mind.**
- **Have a choreographic practice rooted in dance in any form.**
- **Are at any stage in their career.**
- **Are over the age of 18 and not in formal education or training.**
- **Are residents of the United Kingdom and Crown Dependencies (England, Scotland, Wales, Northern Ireland, Isle of Man and Channel Islands).**

We understand that everybody's journey in choreography and dance making is different, so we don't want to define a specific moment in someone's career or suggest a pathway. We ask that you consider the offer and the expertise of the mentors to identify if they would be a good fit for you.

Unfortunately, we won't be able to support:

- **Individuals who are currently part of a Sadler's Wells programme such as Young Associates or are being commissioned or presented by us.**
- **Individuals who are currently in formal education or training.**

- **Those who reside outside of the United Kingdom and Crown Dependencies (such as Republic of Ireland or other EU countries).**

This is a space for the artistic community and is not a place to propose projects to Sadler's Wells for commissioning or programming.

When is it?

The offer is for bi-monthly one-hour remote sessions, a total of six over the course of a year. The exact scheduling of your mentorship should be agreed mutually between each mentee and your mentor.

We expect your first mentoring session to take place no later than the end of September 2023 and the last session in the series of six should be completed before the end of August 2024.

Expression of Interest

In this form, we ask:

- 1. Please tell us about your creative practice.**
- 2. What is your creative question or line of enquiry that you would like to work on with a mentor?**
- 3. Why would you benefit from this Mentorship Programme at this moment in time?**

You can submit your responses to the questions above in either of the following formats:

- Written statements each with a word count of up to 250 words**
- Audio or video recordings each with a duration of 2-3 minutes**

It's best that you prepare your responses before you click through to complete the form. Once you have prepared your responses, the form should take no more than 10-minutes to complete.

We are mindful of the unpaid labour undertaken for open calls and as such invite you to keep your response to the approximate length requested.

This open call launches on Thursday 29 June and you have until **Thursday 3 August at midnight** to apply. You will receive an automatic response when your expression of interest has been received, if you don't receive an e-mail within 24 hours, please contact us via the details at the end of this pack.

Selection Process

This programme will be selected by:

Successful expressions of interest will describe a tangible line of enquiry and highlight the lasting impact a year-long mentorship like this would have on your practice, reflecting the timely nature of this opportunity. We will consider your preferred mentors during the selection process but guarantee you will be paired with one of your choices.

We are committed to foregrounding under-represented voices and as such, we aim to offer at least six of the ten mentorships to:

- **Artists from systemically marginalised groups including, and not limited to, artists with disabilities, artists from the global majority and LGBTQIA+.**
- **Artists that identify as female or non-binary.**

We commit to responding to all who submit an expression of interest by the date above. Should for any reason there be a change to the timeline, we will write to update you.

We anticipate this will be a competitive programme and are regretful that we will receive many more expressions of interest than mentorships we are able to offer. Unfortunately, we will not be able to offer feedback.

Access Requirements

We are committed to being open and inclusive and hope the process is accessible to all but realise that some may still encounter barriers in accessing this offer.

Frequently Asked Questions

Can I apply to work with a specific mentor?

As part of the expression of interest, we will ask you if you could choose, who your top three mentors would be. We will take this into consideration and do our best to pair you with one of your mentors.

What are the financial conditions?

You are not paid for your time as a mentee so please only apply if you are able to dedicate time to this programme. The commitment is six hours over a year-long period. Sadler's Wells will pay the mentors for their time directly.

Is there any kind of public-facing outcome?

No, we do not expect you to share the outcome of this programme publicly, but the impact of the mentorship will be monitored by Sadler's Wells for monitoring and evaluation purposes.

Can I apply if I am already working with Sadler's Wells?

If you are already part of a Sadler's Wells programme like Young Associates, or if you are being commissioned or programmed by us you can't apply.

Is there access support to help me apply?

Yes, the materials are available in large-print plain text and audio. If you need further assistance with access, including our support with the understanding of terms used in this document, we can help. Please use the contact details at the end of this pack.

Are there age restrictions for this programme?

You must be aged 18 or over to apply. We acknowledge that everyone's journey is different, therefore there are no specific age specifications.

Can I apply if I live outside of the United Kingdom?

No, this offer is only available to artists with permanent residence in England, Scotland, Wales, Northern Ireland, Isle of Man and Channel Islands.
